The Forest Glen WSP Update includes planning considerations, existing system conditions, operation and maintenance standards, recommended improvements, and expansion of the service area.

The Capital Improvement Plan (CIP) presented in the WSP consists mainly of physical improvements to the system that are intended to improve Thurston PUDs ability to provide sufficient quantity and quality of water. The projects are defined for a 10-year and 20-year period. However, the CIP projects listed in the WSP should not be viewed as a commitment by Thurston PUD to implement each project as planned and shown in the WSP. Actual project implementation will be based upon environmental review, permits and approvals, available funding and scheduling needs.

This WSP is a non-project action. A separate Washington State Environmental Policy Act (SEPA) review will be completed prior to actual implementation and construction of each individual project as identified on the CIP list. Certain categorical exemptions from the SEPA review process may apply to specific projects, in accordance with WAC 97-11-800.

7. Do you have any plans for future additions, expansion, or further activity related to or connected with this proposal? If yes, explain.

Yes. Owners of the gas station on the corner of Christenson Muck Rd and Mountain Highway contacted the PUD for help. Their well has been contaminated and is no longer usable without expensive treatment. As an act of mutual aid, the PUD authorized the owner of the gas station to pay for a study to evaluate and determine if expansion and inclusion onto the Forest Glen water system was cost-effective. The study concluded inclusion was cost-effective and that the water system could adequately serve the additional connections.

The Department of Health will have final approval of the WSP and once approved they believe the system will be adequate to serve the new connections. This means that the system current infrastructure will be able to maintain current levels of flow and pressure to all customers. The PUD has agreed to service these new connections. If at any time in the future, it is determined that the new services are taxing the water system, the new customer will pay for any upgrades needed.

This water system plan update was developed to meet the requirements of WAC 246-290 and provide comprehensive planning to meet the future water supply requirements for the service area served by the Forest Glen water system.
