Subject: Meeting with PUD Staff

Dear Scattercreek Ranch Water System Customers,

This letter is to inform you about two upcoming public meetings regarding your rates. It is our policy to have standard rates for all of our water systems and compared to other PUD customers, your rates are significantly lower. However, rather than proposing a full increase, we would like to gradually bring you into PUD rates over a two year period. Your proposed rates were developed with the help of a rate consultant that we worked closely with this year. These proposed rates are outlined below and, again, are much lower than most other PUD customers. We have scheduled a meeting close to your home so that we can answer any questions you might have. Information on the meeting location, date and time is listed below.

**What:** Meeting with the PUD's General Manager and Staff

**When:** Tuesday, December 5, 2017 at 7:00 p.m.

**Where:** Tenino High School, 500 West Second Avenue, Tenino, WA 98589

The proposed 2018 rate and surcharge information is outlined below:

- Base charge of \$28.82/month – no consumption allowance included
- Monthly Consumption in cubic feet (cf):

0-500 cf	\$1.29 per 100 cf
501-1,500 cf	\$2.48 per 100 cf
1,501-3,000 cf	\$3.35 per 100 cf
3,001+ cf	\$4.49 per 100 cf

The PUD's monthly capital surcharge will increase to \$6.70 per Equivalent Residential Unit (ERU) effective January 1, 2018. One (1) ERU represents an average single family home. These monies are dedicated to, and are **only** used for, capital improvements and infrastructure replacement.

In addition to the meeting at Rochester High School where my staff and I will be answering questions, there is also a Rate Hearing scheduled. This is your opportunity to address the Board of Commissioners directly. The date, time and location of the Rate Hearing is listed below.
