25 26	ARTICLE III ADMINISTRATION
27 28 29	The Network is administered through Regional Committees and a Statewide Committee.

Only those Regional Committee members appointed by Members are entitled to vote on matters before the Regional Committee. An Associate may be a non-voting member of a Regional Committee. 29	REQUESTS FOR ASSISTANCE

31	A. Member Information: Promptly after executing this Agreement, the signatory
32	Member shall deliver the following to the Statewide Committee: (1) a certified

34	this Agreement and (2) an original signed Agreement. Each Member shall
35	identify an Authorized Official and one alternate Authorized Official. Each

("Request for Assistance"). Requests for Assistance may be made orally or in 1 writing, provided that when a Request for Assistance is made orally, the 2 Requesting Member shall, as soon as practicable, identify and transmit in 3 writing the personnel, equipment and supplies requested. Requesting 4 Members shall direct Requests for Assistance to Authorized Officials. The 5 Statewide Committee shall provide specific protocols for Requests for 6 Assistance as part of the procedures created pursuant to Article IV of this 7 Agreement. 8 9

C. Response to a Request for Assistance - Members are not obligated to 10 respond to a Request for Assistance. After a Member receives a Request for 11 Assistance, the receiving Member's Authorized Official shall evaluate whether 12 to respond to the Request for Assistance, whether resources are available to 13 respond, or if other circumstances would hinder response. Following the 14 evaluation, the Authorized Official shall inform, as soon as possible, the 15 Requesting Member whether the Member will respond to the Request for 16 Assistance. If the Member is willing and able to provide assistance, the 17 Member shall inform the Requesting Member of the type of available 18 resources and the approximate arrival time of such assistance. 19 20 D. Discretion of Responding Member's Authorized Official – No Member has any 21 duty to respond to a Request for Assistance. When a Member receives a 22 Request for Assistance, the Authorized Official shall have sole and absolute 23

discretion as to whether or not to respond to the Request for Assistance, and 24 if responding in the affirmative, to determine the availability of resources to be 25 made available to the Requesting Member. The response of a Member's 26 Authorized Official regarding the availability of resources to a Requesting 27 Member shall be final. 28

E. No Liability for Failure to Respond – No Member will be liable to any other 30 Member for deciding not to respond to a Request for Assistance or otherwise 31 failing to respond to a Request for Assistance. All Members hereby waive all 32 claims against all other Members arising from or relating to any Member's 33 decision to not respond to a Request for Assistance or to any Member's failure 34 to respond to a Request for Assistance. 35

### ARTICLE VI **RESPONDING MEMBER PERSONNEL**

A. National Incident Management System - When providing assistance under 41 this Agreement, the Requesting Member and Responding Member are 42 encouraged (but are not obligated) to be organized and function under NIMS. 43 44

B. Coordination and Records – Employees of the Responding Member will 1 remain under the direction and control of the Responding Member to the 2 fullest extent possible. The Responding Member is an independent 3 contractor at all times. The Requesting Member's Authorized Official shall 4 coordinate response activities with the designated supervisor(s) of the 5 Responding Member(s). The Responding Member's designated supervisor(s) 6 shall keep accurate records of work performed by personnel during the Period 7 of Assistance and for the equipment and supplies provided during work. 8 9 C. Food and Shelter – Whenever practical, Responding Member personnel must 10 be self sufficient for up to seventy-two (72) hours. Whenever practical, the 11 Requesting Member shall supply adequate food and shelter for Responding 12 Member personnel. If the Requesting Member is unable to provide food and 13

- shelter for Responding Member personnel, the Responding Member's
   designated supervisor is authorized to secure the food and shelter necessary
   to meet the needs of its personnel.

D. Communication - The Requesting Member shall provide Responding 18 Member personnel with communications equipment as available, radio 19 frequency information to program existing radios if appropriate, or telephone 20 contact numbers, in order to facilitate communications with local responders 21 and utility personnel. Each Requesting Member shall provide contact 22 information for an individual with whom Responding Member's personnel may 23 coordinate while en-route for access, staging instructions and other logistical 24 requirements. 25

- E. Status Unless otherwise provided by law, the Responding Member's officers and employees shall have the same powers, duties, rights, privileges, and immunities as if they were performing their duties in the jurisdiction in which they are normally employed.

F. Licenses and Permits – To the extent permitted by law, Responding Member
 personnel that hold licenses, certificates, or permits evidencing professional,
 mechanical, or other skills shall be allowed to carry out activities and tasks
 relevant and related to their respective credentials during a Period of

### ARTICLE VII RIGHT TO WITHDRAW RESOURCES

- A. Right to Withdraw A Responding Member may withdraw some or all of its
   resources at any time for any reason, as determined in the Responding
   Member's sole and absolute discretion. The Responding Member shall

communicate written or oral notice of intention to withdraw all or some of a 1 Responding Member's resources to the Requesting Member's Authorized 2 Official as soon as practicable under the circumstances. To the greatest 3 extent possible, but without limiting in any way a Responding Member's sole 4 and absolute discretion, a Responding Member's determination to withdraw 5 some or all of its resources provided to a Requesting Member should 6 consider the status of the incident and incident stability, to minimize any 7 adverse impacts from the withdrawal of resources by a Responding Member. 8 9 B. No Liability for Withdrawal - No Member will be liable to any other Member 10 for first responding to a Request for Assistance by providing resources (such 11 as personnel, materials, and equipment) and later withdrawing or refusing to 12 continue to provide some or all of those resources. All Members hereby 13 waive all claims against all Members arising from or relating to such a 14 withdrawal or refusal. 15 16 17 ARTICLE VIII 18 **COST- REIMBURSEMENT** 19 20 The Requesting Member shall reimburse the Responding Member for all costs 21 incurred by the Responding Member during a Period of Assistance, unless 22 otherwise agreed in writing by both Members. 23 24 A. Personnel – The Requesting Member shall reimburse the Responding 25 Member for personnel costs incurred for work performed during a Period of 26 Assistance. Responding Member personnel costs will be calculated according 27 to the terms provided in their employment contracts, hourly rate schedules or 28 other conditions of employment. The Responding Member's designated 29 supervisor(s) shall keep accurate records of work performed by personnel 30 during a Period of Assistance. The Requesting Member shall include in its 31 reimbursement of the Responding Member all personnel costs, including 32 salaries or hourly wages, costs for fringe benefits, and indirect costs. 33 34 Unless otherwise agreed in writing, the Requesting Member shall reimburse 35 the Responding Member for all reasonable and necessary costs associated 36 with providing food and shelter for the Responding Member's personnel, if the 37 food and shelter are not provided by the Requesting Member. The 38 Requesting Member is not required to reimburse the Responding Member for 39 food and shelter costs in excess of State per diem rates unless the 40 Responding Member demonstrates in writing that the excess costs were 41 reasonable and necessary under the circumstances. 42 43

B. Equipment – The Requesting Member shall reimburse the Responding 1 Member for the use of equipment during a Period of Assistance, including, but 2 not limited to, reasonable rental rates, all fuel, lubrication, maintenance, 3 transportation, and loading/unloading of loaned equipment. The Requesting 4 Member shall return all equipment to the Responding Member in good 5 working order as soon as is practicable and reasonable under the 6 circumstances. If equipment cannot be returned in good working order, then 7 Requesting Member shall either provide in-kind replacement equipment to 8 Responding Member at no cost to Responding Member or pay to Responding 9 Member the actual replacement cost of the equipment. Reimbursement rates 10 for equipment use will be no less than the Federal Emergency Management 11 Agency's (FEMA) Schedule of Equipment Rates. If a Responding Member 12 uses rates different from those in the FEMA Schedule of Equipment Rates, 13 the Responding Member shall provide such rates orally or in writing to the 14 Requesting Member prior to supplying the equipment. If reimbursement rates 15 are to be different than those in the FEMA Schedule of Equipment rates, 16 Responding Member and Requesting Member shall agree in writing on which 17 rates will be used prior to dispatch of the equipment to the Requesting 18 Member. Requesting Member shall reimburse for equipment not referenced 19 on the FEMA Schedule of Equipment Rates based on actual recovery of 20 costs. If a Responding Member is required to lease equipment while its 21 equipment is being repaired because of damage due to use during a Period of 22 Assistance, Requesting Member shall reimburse Responding Member for 23 such rental costs. 24

25

C. Materials and Supplies - The Requesting Member shall reimburse the 26 Responding Member in kind or at actual replacement cost, plus handling 27 charges, for use of expendable or non-returnable supplies by the Responding 28 Member during a Period of Assistance. The Responding Member shall not 29 charge direct fees or rental charges to the Requesting Member for other 30 supplies and reusable items that are returned to the Responding Member in a 31 clean, damage-free condition. Reusable supplies that are returned to the 32 Responding Member with damage will be treated as expendable supplies for 33 purposes of cost reimbursement. 34

D. Payment Period – In order to be reimbursed, the Responding Member shall 36 provide an itemized bill to the Requesting Member no later than ninety (90) 37 days following the end of the Period of Assistance for all expenses incurred 38 by the Responding Member while providing assistance to a Requesting 39 Member under this Agreement. The Responding Member may request 40 additional time to submit the itemized bill, and Requesting Member shall not 41 unreasonably withhold consent to such a request. The Requesting Member 42 shall pay the itemized bill in full on or before the forty-fifth (45<sup>th</sup>) day following 43 the billing date. The Requesting Member may request additional time to pay 44

the itemized bill, and Responding Member shall not unreasonably withhold 1 consent to such a request, but in no event will payment in full occur later than 2 one year after the date a final itemized bill is submitted to the Requesting 3 Member. If a Responding Member disputes a portion of an itemized bill, the 4 Requesting Member shall promptly pay those portions of the bill not under 5 dispute, pending the resolution of the payment of the disputed portion of the 6 bill. 7

E. Records - Where a Responding Member provides assistance to a Requesting 9 Member under this Agreement, both Members shall provide the other 10 Member access to the books, documents, notes, reports, papers and other 11 records relevant to this Agreement for the purposes of reviewing the accuracy 12 of a cost bill or making or undergoing a financial, maintenance or regulatory 13 audit. Both Members shall maintain these records for at least three (3) years 14 or longer where required by law. 15
